Basco Nig, a black Labrador owned by John Nendiguerin, Ontario, Ore., won the junior stake for dogs under 24 months. Basco Nig was rated for first place over Montana Copper Key, a Chesapeake, owned by Peter Brooks of Boise.

Grouse of Trabington outpointed Dr. John Lundy's High Test Pride of Marcroft, a Chesapeake, and Basco Nig in taking the day's feature event.

German Shorthair Competes

In a special stake for dogs other than retrievers, Tom McGuire's German shorthair pointer, Waldwinkel Teresa, was the only animal to successfully complete both land and water trials, though Wizard, a German Weimaraner owned by Mrs. Fentress Kuhn, finished in first place in water events.

A national field trial champion, Brignall's Gringo, male Labrador, outperformed all entries in winning the open all-age stake at the Idaho Retriever Trial Club's first AKC sanctioned trial April 24, held at the Lake Lowell game refuge south of Nampa. Gringo, youngest dog ever to win the top honors and the only one from the west during the eight years the trials have been conducted, was handled by his owner, Clifford N. Brignall of Long Beach, Calif.

On Saturday the retriever enthusiasts from Oregon, California, Washington and Idaho put their dogs through their trials to determine winners of the junior stake—for dogs under two years of age—and the amateur handler stake, which includes any retriever handled by a non-professional. Junior stake winner was a Labrador male from Oregon—Ranger of Beaverstate. Judy of Modoc, a golden Labrador from California. owned and handled by T. R. Bazon of Candy, Calif., won the amateur-handled stake. Ranger of Beaverstate is owned by E. L. Kinnaman of Portland.

Winner of the Idaho state trophy was Aleutian Water Queen, a Chesapeake female owned by Robert Walker of Boise. The dog was competing in first trial in the junior stakes.
