



General Rules and Guidelines

1. Nominations will be accepted by November 15th prior to the annual meeting
2. Applications will be reviewed for approval by the IRC Board of Governors on or before December 31 of that year.
3. The current Governing Board makes recommendations' to the general membership for approval at the annual meeting.
4. There will be perpetual trophies, one representing dogs that are so honored and one for individuals so honored will be maintained by the IRC and Displayed at the annual meeting and at any other events deemed appropriate. In addition a Plaque of recognition and a certificate will be presented to the Individual or owner.
5. The individual or dog if approved will be recognized at the Annual Membership Meeting held in January of the following year.
6. All recipients will be included on the IRC website Hall of Fame Tab with a synopsis of the individual's contributions or the dog's accomplishments.
7. Any active IRC member can nominate an individual or dog for consideration by the IRC Board of Directors. Qualifications must be documented by date and place and defined by accomplishment
8. No more than three additions to individuals and three additions to dogs will be made to the Hall of Fame annually.

Idaho Retriever Club (IRC) Hall of Fame Requisites for individuals

- Membership with IRC for a minimum of three years (only current or deceased members are eligible for nomination). The nominated individual must meet a minimum of five of the following criteria.

Criteria for individuals

- Judged a National Amateur or Open Event
- Judged a Master national Hunt Test
- Qualified a dog as a FC, AFC or NMH title (# Master National Qualifying Scores)
- Qualified a dog for national field trial competition
- Handled a dog in a national Field Trial Competition
- Judged 8 or more AKC all age events
- Judged 8 or more minor stakes
- Judged 8 or more Hunt test events at the master level
- Served as an officer or on board of directors of an AKC Club for 4 or more years
- Delegate/representative of the AKC
- Participated in judges seminars
- Participated in the conduct of educational events for the betterment of our sport
- Served on a national event committee
- Served on Rules Committee (nationally or locally)
- Served on a Field Trial or Hunt Test Committee
- Whole or partial owner of a dog that competes in AKC Hunt Tests and / or Field Trials

Idaho Retriever Club (IRC) Hall of Fame Requisites for Dogs

Criteria for Dogs

- Whole or partially owned by a member of IRC for three years during its career
- Retired or deceased

The nominated dog must meet a minimum of three of the following criteria

- 10 or more Derby career points
- Qualified all age
- Master Hunter
- 10 or more AKC retriever field trial All Age points
- AKC Field Champion
- AKC Amateur Field Champion
- Passed a master national hunt tests
- Qualified for two or more Master National Hunt Tests
- Winner or finalist of either the Amateur National or National Open (Automatic Induction into Hall of Fame)
- Qualified or Competed in a National Open
- Qualified or Competed in a National Amateur
- Produced two or more puppies on Derby List, Qualified All Age or Master Hunter



NOMINATION FORM FOR THE IRC HALL OF FAME

Nomination must be submitted to the club secretary by November 1st of the current year. The board of Governors will review and determine eligibility by December 1st of the current year. Announcements will occur at the Annual Meeting and Banquet.
